Inc. respectfully requests administrative approval of a 160 acre non-standard proration (NSP) unit for its ~~Owen~~ Meredith #2 well, located 660' FSL and 660' FEL of Section 19, T-21-S, R-36-E, Lea County, New Mexico. The proposed NSP unit will consist of the east half of the east half of Section 19, which includes a 40 acre tract of Getty's, and in effect is a request for reassignment of the 160 acre NSP unit formerly assigned to our Owen Meredith #1 well, shut-in since September 1974. ^{com}




EUMONT FIELD


