
Gentlemen:

Please refer to my letter of December 18, 1978 concerning the above captioned well. I failed to mention that this section 18 of T31N-R9W is located on a correction line thereby causing the west half of the section to contain only 201.47 acres. A copy of the survey of section 18 is attached along with a Well Location and Acreage Dedication Plat (Form C-102).

It is our understanding that Union Texas Petroleum Division of Allied Chemical has dedicated the west half of section 7 to a Pictured Cliffs well in the Blanco Pictured Cliffs Pool in the same manner as we propose to dedicate the west half of section 18 to a Pictured Cliffs well.


Gentlemen:


