





Enclosed are plats showing location of our proposed 160 acre non-standard Queen gas unit on the above well, lease plat, and a list of offset operators to whom certified letters were sent requesting their approval.

Our #1 Holbrook-Federal produces about 1,000 to 2,000 MCF per month and is on a communitized 320 acre gas unit comprising the W 1/2, Sec. 9.

We have completed our #1 Holbrook-Federal "B", 660' FS & WL, Sec. 9, 15S-30E, as a Queen oil well in the oil rim downdip from the #1 Holbrook-Federal gas well. As we could conceivably drill four wells in the SW 1/4, Sec. 9, we wish to dedicate the NW 1/4, Sec. 9 to a non-standard gas unit and delete the SW 1/4 from the existing unit.

In accordance with R-5353 of the General Associated Pool Rules, we respectfully request administrative approval of a non-standard Queen gas unit to be located in the NW 1/4, Sec. 9,
