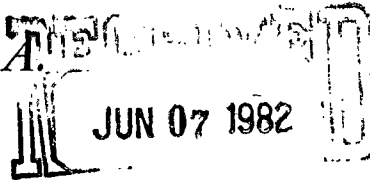

Township 20 South, Range 39 East, NMPM






