

Per your letter dated November 12, 1985, Division Administrative Orders Nos. NSP-1450 and NSP-1451 (as amended) approving an 80-acre non-standard proration unit in the Baum Upper Pennsylvanian Pool comprising the S/2 SE/4 of said Section 17 dedicated to the Baum 17 "B" Well No. 1 (located 660' FS & EL) and an 80-acre non-standard proration unit also in the Baum Upper Pennsylvanian Pool comprising the N/2 SE/4 of said Section 17 dedicated to the Baum 17 "B" Well No. 2 (located 1980' FSL - 660' FEL), respectively, are hereby rescinded.
