

Gentlemen:

Texaco Inc. respectfully requests that an 80-acre non-standard gas proration unit be approved for the referenced well. The well will be completed in the Maljamar Queen (Gas) pay zone.

This request was previously submitted on November 2, 1987. Lynx Petroleum protested the application and the case was inadvertently withdrawn by our lawyers in a letter dated January 5, 1988, rather than being postponed. An agreement with Lynx Petroleum has been made and they will not protest this request.

Attached are Form C-102 showing the proposed 80-acre proration unit, a plat of the lease showing offset operators, and a list of Offset Operators that have been notified of this second request by a copy of this letter.




