Gentlemen:

Chevron U.S.A. Inc. respectfully requests your approval of our administrative application for a 40-acre Non-Standard Gas Proration Unit in the Jalmat Tansil-Yates-Seven Rivers (Prorated Gas) Pool comprising the NE/4 SE/4, Section 32, T-25-S, R-37-E, NMPM, Lea County, New Mexico. This acreage will be dedicated to our Arnott Ramsay (NCT-B) Well No. 7. In support thereof, Chevron U.S.A. Inc. states the following facts:

- 1) That NMOCD Administrative Order NSP-210 (amended) and SD-81-5 approved a 320-acre Non-Standard Gas Proration Unit, consisting of E/2 of Section 32, T-25-S, R-37-E and simultaneous dedication of said acreage to Arnott Ramsay (NCT-B) Wells No. 2 and 7.
- 2) That pursuant to an agreement in April, 1985, Doyle Hartman acquired Chevron's Jalmat rights in the 280-acres comprising the NE/4, W/2 SE/4 and SE/4 SE/4 Section 32, T-25-S, R-37-E, NMPM. This reduced Chevron's Jalmat rights, hence proration unit, to the subject 40-acres.
- 3) That in May, 1986, Well No. 2 was temporarily abandoned thus eliminating the need for a MWU classification. This well has been disconnected.
- 4) That by Order NSP-1583, signed September 12, 1989, the 280-acres, delineated in Item 2 above, was dedicated to Doyle Hartman's Arnott Ramsay (NCT-B) Well No. 13 in Unit O of said Section.

7) The proposed Non-Standard Gas Proration Unit complies with the following provisions:

- a) The proposed unit consists of 40-acres that are contiguous.
- b) The proposed unit lies wholly within a single governmental quarter-section in the Jalmat Tansil-Yates-Seven Rivers (Prorated Gas) Pool.
- c) The entire proposed unit may reasonably be presumed to be productive of gas from the Jalmat Tansil-Yates-Seven Rivers (Prorated Gas) Pool.
- d) A copy of this application will be sent by certified mail to all offset operators and operators owning interests in the proposed unit's boundary and shall serve as notification.

In support of this application, attached is a plat outlining the proposed 40-acre Non-Standard Gas Proration Unit to be dedicated to our Arnott Ramsay (NCT-B) Well No. 7 and a map showing all offset operated properties and wells.

In view of the facts submitted, Chevron U.S.A. Inc. requests that administrative approval of the subject 40-acre Non-Standard Gas Proration Unit comprising the NE/4 SE/4 Section 32, T-25-S, R-37-E, be granted.
