Dear Ms. Williams:

Reference is made to your application dated November 16, 1994, for a non-standard Jalmat gas well location in an existing non-standard 120-acre gas spacing and proration unit (GPU) for said Jalmat Gas Pool comprising the NW/4 SW/4 and S/2 NW/4 of Section 33, Township 25 South, Range 37 East, NMPM, Lea County, New Mexico. Said GPU was authorized by Division Administrative Order NSP-1661(SD), dated February 1, 1993 and currently has dedicated thereon the El Paso Tom Federal Well No. 7 (API No. 30-025-11881), located at a standard gas well location 1980 feet from the South line and 660 feet from the West line (Unit L) of said Section 33.

It is our understanding that the subject well to be considered in this application is currently a producing oil well in the Langlie-Mattix Pool and upon issuance of this order will be recompleted up-hole into the Jalmat Gas Pool.

By authority granted me under the provisions of Rule 2(c) of the Special Rules and Regulations for the Jalmat Gas Pool, as promulgated by Division Order No. R-8170, as amended, the following described well located at an unorthodox Jalmat gas well location is hereby approved:

***R. O. Gregory Well No. 3
330' FSL - 660' FWL (Unit M) of said Section 33
API No. 30-025-11874***

Also, you are hereby authorized to simultaneously dedicate Jalmat gas production from the El Paso Tom Federal Well No. 7 with the R. O. Gregory Well No. 3. Furthermore, you are hereby permitted to produce the allowable assigned the subject GPU from both wells in any proportion.



Per your application dated April 2, 1993, you are hereby authorized to simultaneously dedicate Jalmat Gas Pool production to the previously approved non-standard 160-acre gas spacing and proration unit comprising the NW/4 NW/4, S/2 NW/4, and NE/4 SW/4 of Section 33, Township 25 South, Range 37 East, NMPM, Lea County, New Mexico (Division Order NSP-1661(SD), dated February 1, 1993), from the existing El Paso Tom Federal Well No. 5 located at a standard gas well location 1650 feet from the North line and 660 feet from the West line (Unit E) of said Section 33 and to the El Paso Tom Federal Well No. 9 to be recompleted from the Langlie Mattix Pool and located at a standard gas well location 660 feet from the North and West lines (Unit D) of said Section 33.

Further, you are permitted to produce the allowable assigned said 160-acre unit from both wells in any proportion.

Reference is made to your application on behalf of the operator Lanexco, Inc. by letter dated September 23, 1992 for an unorthodox Jalmat gas well location in an existing non-standard 440-acre gas spacing and proration unit (GPU) for said Jalmat Gas Pool comprising the NW/4 NW/4, S/2 NW/4, and S/2 of Section 33, Township 25 South, Range 37 East, NMPM, Lea County, New Mexico. Said GPU was authorized by Division Order No. R-687, dated September 15, 1955 and had dedicated thereon the El Paso Tom Federal Well No. 6 located at a standard gas well location 1650 feet from the South and East lines (Unit J) of said Section 33.

By Division Order No. R-6511, dated November 6, 1980, an additional well recompleted to the Jalmat Gas Pool from the Langlie - Mattix Pool, the El Paso Tom Federal Well No. 7 (formerly the Gregory "A" Federal Well No. 2), located at an unorthodox gas well location 1980 feet from the South line and 660 feet from the West line (Unit L) of said Section 33 was approved for said GPU.

By Division Order No. R-6511-A, dated November 2, 1983, a third well to be drilled and completed in the subject GPU was approved for the El Paso Tom Federal Well No. 5 located at an unorthodox gas well location 1650 feet from the North line and 660 feet from the West line (Unit E) of said Section 33.

By the authority granted me under the provisions of Rule 2(c) of the Special Rules and Regulations for the Jalmat Gas Pool, as promulgated by Division Order No. R-8170, as amended, the following described well to be drilled at an unorthodox gas well location is hereby approved:
