Dear Mr. LeMay:

Chevron U.S.A. is planning to recomplete the Arnott Ramsey (NCT-D) # 9 in the Jalmat YTS-7RVRS Gas Pool. The well currently is completed in the Jalmat (7RVRS) Oil Pool and the Eunice South (QN) Oil Pool. The location of the proposed recompletion is 1980' FSL and 660' FWL in Section 33, T21S, R36E, Lea County, New Mexico.

The captioned well is on an existing standard 40-acre Jalmat oil spacing and proration unit which comprises of the NM/4, SW/4 of Section 33, T21S, R36E. Arnott Ramsey NCT-D wells # 6, 7, & 8 are all Jalmat Oil Pool (7RVRS) wells and Eunice South Oil Pool (QN) wells that are commingled downhole and dedicated to their own 40 acre units. The production from these four wells has become marginal. Wells 7 and 8 will be SI and well 6 is already SI, to allow for the dedication of this 160 acres to the Jalmat Gas Pool using well # 9. Because the location of the subject well is 660' from the west boundary of the 160-acre GPU, it is at a standard location for a 160 acre Jalmat GPU.

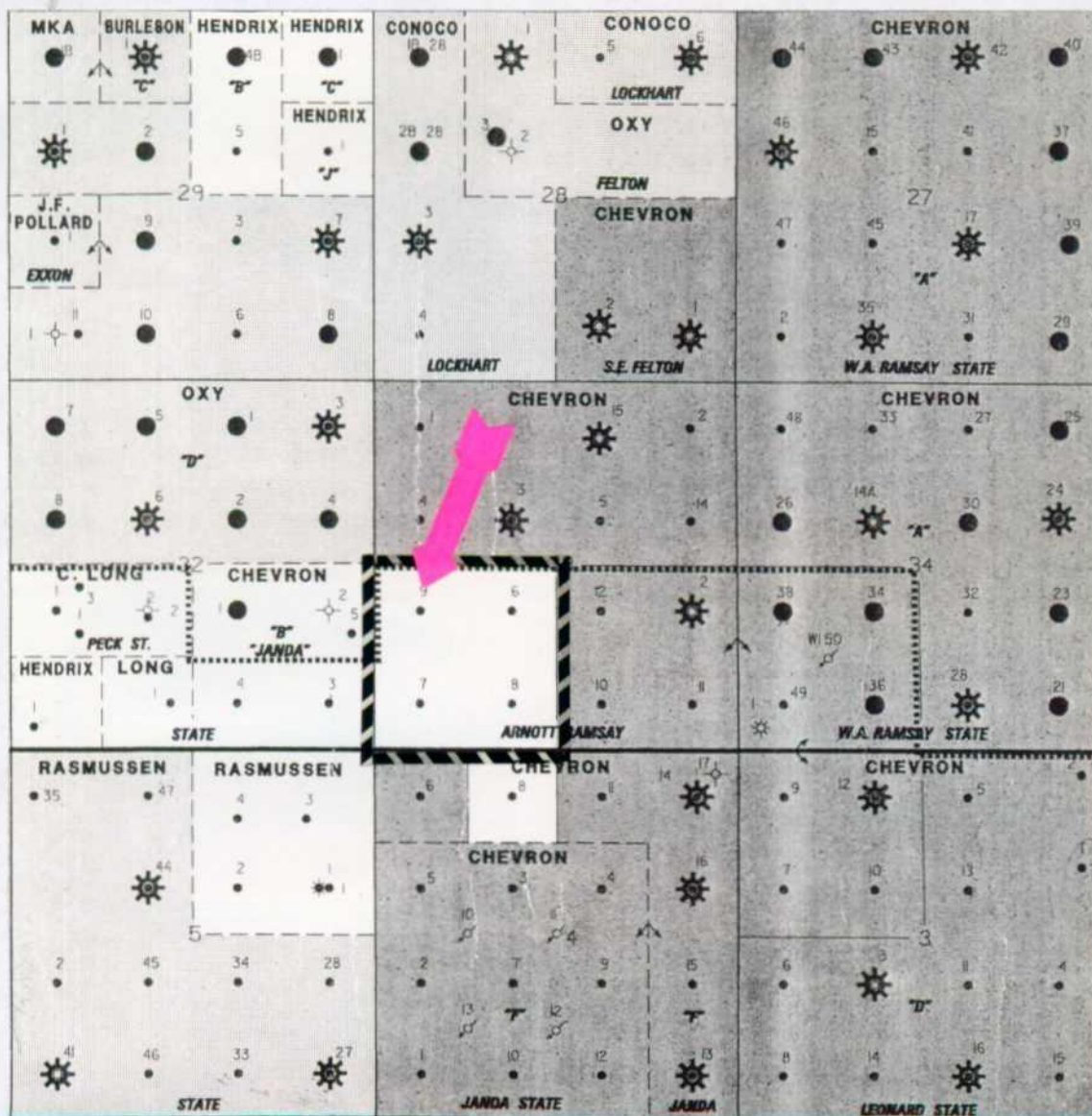


