A Division of Interest dated 3/24/94 was furnished to Erwin Oil & Gas Ltd., Inc. by Primero Operating Inc. on the NW/4 SW/4 of Section 19. Primero operated the above lease from 11/93 to 3/94 and they obtained the Division of Interest from Shell Western E & P, Inc.

In response to my request for a copy of the Division of Interest for the entire SW/4, Shell furnished the Division of Interest dated 9/9/96.

In comparing these Division of Interests I find the following differences:
