On 2-7-02 SITP was 675 psi. Released packer. Modified R packer set at 4370'. Acidize with 1000 gallons 20%IC HCL and ball sealers.

On 2-13-02 Rigged down pulling unit. SITP at 700 PSI, IFL at 3700', Gas analysis BTU Dry=1034.99 BTU Wet=1016.98
