
REPORTER'S TRANSCRIPT OF PROCEEDINGS

These matters came on for hearing before the New Mexico Oil Conservation Division, WILLIAM V. JONES, JR., Hearing Examiner, on Thursday, February 5th, 2004, at the New Mexico Energy, Minerals and Natural Resources Department, 1220 South Saint Francis Drive, Room 102, Santa Fe, New Mexico, Steven T. Brenner, Certified Court Reporter No. 7 for the State of New Mexico.

WHEREUPON, the following proceedings were had at 1 2 8:15 a.m.: EXAMINER JONES: Okay, let's call the hearing to 3 4 order. This is the Docket Number 04-04 Examiner Hearing, 5 Thursday, February the 5th, 2004. And first let's call the 6 7 continuances and dismissals. 8 On the first page, Case 13,210 is dismissed, Case 9 13,205 continued to February 19th, Case 13,175 continued to 10 March 18th. 11 And the second page, Case 13,210 [sic] is continued to March the 4th, and Case 13,212 is continued to 12 March the 4th. 13 And the last page, Case 13,144 -- Scott Hall is 14 15 not here today, but that would be the sixth continuance of this case, so... I think we're going to go ahead and 16 continue it one more time, but I'll call Scott Hall about 17 18 that. Any other continuances or dismissals? 19 20 MR. BRUCE: Mr. Examiner, since we're still kind of witness-short here at the time, at the bottom of page 2, 21 22 the Case 13,203, Application of John R. Stearns, I believe Mr. -- that case was originally filed administratively for 23 an unorthodox gas well location. There was an objection, 24 25 so it was set for hearing.

Because no one showed up, I 3 asked that it be referred back to the administrative 4 docket. So I would ask that you call that docket, and if 8 no one else appears then the case would be dismissed 9 because of an administrative order. 10 11 EXAMINER JONES: Okay. Thanks, Mr. Bruce.
