Dear Mr. Bruce:

Reference is made to your request dated April 7, 2004 on behalf of Mewbourne Oil Company for a 90-day extension of time in which to complete the Lonetree "14" State Com Well No. 1. Ordering Paragraph No. (4) of Division Order No. R-12056 stipulated that:

"(4) Should the proposed well not be drilled and completed within 120 days after commencement thereof, Ordering Paragraph (1) shall be of no further effect, and the unit created by this Order shall terminate unless the operator appears before the Division Director and obtains an extension of time to complete the well for good cause demonstrated by satisfactory evidence."

Division records show that drilling operations on the Lonetree "14" State Com Well No. 1 commenced on November 24, 2003. Pursuant to the provisions of Order No. R-12056, the well was to have been completed by March 22, 2004. Since the well was not completed by that date, and since your request to extend the completion time for the well was not received by the Division until April 8, 2004, it appears that Order No. R-12056 has expired.

Your request for a 90-day extension of time to complete the Lonetree "14" State Com Well No. 1 is hereby denied. Reactivation of Division Order No. R-12056 will require a hearing before a Division examiner.



The above order, dated November 25, 2003, required the operator to commence the Lonetree "14" State Com. Well No. 1 by March 1, 2004, and drill the well to completion within 120 days. Mewbourne drilled the well to its proposed total depth, but the well was not completed as a producer. However, re-entry operations are contemplated, and Mewbourne requests that Ordering Paragraph (4) of the order be amended to allow the operator 210 days from well commencement to complete the well.
