A review of the Division's correspondence file in this matter will reflect that this case has been the subject of numerous continuances in the past few months. On behalf of the Applicant, I again request the hearing on the Application be continued, this time to the April 29, 2004 Examiner hearing docket.

The Hilburn No. 3 well is the third re-entry through the same well bore drilled to the Strawn formation with a resulting bottom hole location that is closer to a standard location than the current unorthodox surface location. In addition to approval of the unorthodox location, Permian sought a pool rules amendment to change the acreage dedication requirement in the North Shoe Bar-Strawn Pool from 80 acres to 160 acres. Permian will dismiss this aspect of the Application, leaving only the unorthodox location for the Division's review and approval.

Since its completion in October, 2003, the well has been unable to sustain a flow of measurable amounts. Permian is planning to re-stimulate the well and place it on artificial lift, but for a number of reasons, it has been prevented from scheduling the work. Until the work is done and production data obtained, Permian will not have the necessary information to include in a production restriction agreement it proposes to enter into with two offsetting operators, EOG and Yates Petroleum, both of whom have been cooperative. The delay in finalizing the production restriction agreement has also delayed the planned submission of an application for administrative approval of the unorthodox well location.

Continuation of the matter until the April 29<sup>th</sup> docket should allow the Applicant ample time to complete its evaluation of the well and provide the Division with the application materials for administrative approval, based on the notice that has been provided in the docketed case.
