MOTION FOR CONTINUANCE

CHASE OIL CORPORATION and CHASE FARMS ("Chase"), through its undersigned attorneys, files this motion for a continuance of the April 29, 2004, examiner hearing on this application, and is support of its motion states:

1. Chase Energy Coroporation and Chase Farms are interest owners in the N/2 of Section 29, Township 17 South, Range 26 East which is the subject of the compulsory pooling application filed in this matter by Preston Exploration, L.L.C. ("Preston")

2. Preston seeks an order poling the N/2 of Section 29. Mack Energy Corporation owns 33.33% working interest in the proposed spacing unit and Chase Farms owns a 4.1667% royalty interest and surface rights. The surface, with the exception of a small portion owned by Denis C. Riley, is owned by Chase Farms.

3. Preston staked the location for the well at a point 1480 feet from the North and West lines of Section 29. By letter dated February 18, 2004, Chase Farms advised Preston that this location was unacceptable. Since that time the parties have continued to negotiate.

4. In the course of these negotiations, Preston assured Chase Farms that they would not utilize the Chase Farms surface but would locate the well in the NW/4 NW/4 of Section 29. Attached to this Motion as Exhibit A is an e-mail from Preston's land representative assuring Chase Farm that their proposed well would not be located on the Chase Farm surface estate.

5. As of April 6, 2004, Chase Energy Corporation understood that Preston had agreed to move the surface location for this off the Chase Farms surface to a location 1200 feet from the North line and 1280 feet from the West line of Section 29. A copy of the last letter from

Preston Exploration, L.L.C., dated April 6, 2004, that shows this location is attached to this motion as Exhibit B.

6. On April 23, 2004, Chase received Preston's Pre-Hearing Statement in this case. This Pre-Hearing Statement is silent on the proposed well location. A copy of this Pre-Hearing Statement is attached to this Memorandum as Exhibit C.

7. On April 27, 2004, Chase was advised for the first time that Preston no longer proposes to drill at a location in the NW/4 NW/4 of this Section as it had agreed but, instead, was moving the well to a location on the Chase surface 1450 feet from the North line and 1980 feet from the West line of Section 29, 2004.

8. Chase fully intends to participate in this pooling hearing. However, it relied on the representations of Preston, has been taken by surprise by this change in well location, and it is now impossible for its witnesses to be present in Santa Fe for the hearing on April 29, 2004.

WHEREFORE, Chase Oil Corporation and Chase Farms, moves the Division for a continuance of this case to the examiner hearing scheduled May 13, 2004.

We are willing to acquire your leases at a reasonable cost under a term assignment whereby you turn a 75% net lease. We are not interested in a farmout of your interest with a 1/3 backin after payout.

Bo:

We've discussed your proposal for surface use in the N/2 of Section 29, T17S, R26E. We also noticed you apparently are going to propose a different bottom hole location for your initial well.

For various reasons, your proposed surface location is unacceptable to Chase Farms. However, we are willing to begin negotiations with you based on the following general terms:

Drill your initial well in the W/2 of the spacing unit with your surface location in the area I recommended in the NW/4 NW/4. From there, you can drill a vertical hole or a directional hole to a bottom hole location of your choice.

If you desire to drill a subsequent well with a bottom hole location in the E/2 of the spacing unit (within an agreed time frame), Chase Farms will make a surface location available to you in the NE corner of the SE/4 NE/4, adjacent to US Hwy 285. This will allow you to drill directionally in a SW direction to your desired bottom hole location.

Chase Oil Corporation owns 1/3 of the leasehold in your N/2 spacing unit. Chase Oil does not desire to participate in your well(s). However, if you agree to the general terms above, Chase Oil will farmout its leasehold to you with no cash consideration or reserved overriding royalty, but with the option to back in to a proportionately reduced 1/3 working interest after payout of each well.

In the alternative, Preston would like to negotiate a term assignment of your leasehold right in the N/2 of Section 29.


