STATEMENT OF THE CASE

Chesapeake Operating, Inc., in accordance with Section 70-1-17.C seeks a compulsory pooling order pooling all mineral interest from the surface to the base of the Wolfcamp formation underlying a standard 40-acre spacing unit consisting of the SE/4NW/4 of Section 27, T12S, R38E, Lea County, New Mexico for its Burrus "27" Well No. 9 to be drilled as an unorthodox oil well location in Unit F of this section and the designation of Chesapeake Operating Inc. as the operator plus the standard provisions of the Division's compulsory pooling order including a 200% risk factor penalty in accordance with Commission Order R-11992, effective August 15, 2003.

The proposed unorthodox location is 1473 feet FNL and 2306 feet FWL of this section and based upon 3-D seismic interpretation demonstrates that this location is necessary to produce oil that cannot be accessed at the closest standard location.
