APPLICATION FOR TECHNICAL AMENDMENT OF RULE 1107

- 1. Rule 1107 provides for a form denominated form C-107 for use in connection with applications for multiple completions.
- 2. Rule 303.C refers to a form denominated form C-107A for use in connection with applications for downhole commingling. However, there is no reference to form C-107A in Part 13 of the Commission's rules where official forms are described.
- 3. Recently adopted amendments to Rules 303.B and 303.C refer to a form denominated form C-107B for use in connections with applications for surface commingling. However, there is no reference to form C-107B in Part 13 of the Commission's rules where official forms are described.
- 4. The Division proposes to amend Rule 1107 [19.15.13.1107 NMAC] to describe forms C-107A and C-107B. The text of the proposed amendment is attached to this Application as Exhibit A.

WHEREFORE, the Engineering Bureau Chief of the Division hereby applies to the Commission to enter an order:

A. Adopting amended Rule 1107 as set forth in Exhibit A hereto.

B. Granting such other and further relief as the Commission deems appropriate.

- B. Form C-107A, when applicable, shall be filed in accordance with Subsection C of 19.15.5.303 NMAC.
- C. Form C-107B, when applicable shall be filed in accordance with Subsections B and D of 19.15.5.303 NMAC.
