

Dear Mr. Carr:

On behalf of Chesapeake Operating Inc. ("Chesapeake"), this letter confirms the agreement of Chesapeake and you client, Yates Petroleum Corporation ("Yates") that Chesapeake in exchange for Yates' waiver of objection to Case 13267, Chesapeake waives objection in the event that Yates recompletes its Big Flat ASN Well No. 2 in the Upper or Middle Atoka portion of the North Shoe Bar-Atoka Gas Pool at an unorthodox gas well location not closer than 330 feet FSL and FEL of Section 10, T16S, R35E, NMPM, Lea County, New Mexico. This would entail deepening the Big Flat ASN #2 Well No. 230 feet to be at an equivalent stratigraphic total depth as the Boyce "15" #5 well.
