STATEMENT OF THE CASE

APPLICANT

Applicant seeks an order pooling all mineral interests from the surface to the base of the Montoya formation underlying the following described acreage in Section 23, Township 7 South, Range 26 East, NMPM, and in the following manner: the W $\frac{1}{4}$ to form a standard 320-acre gas spacing and proration unit for any and all formations and/or pools developed on 320-acre spacing within that vertical extent, including but not limited to the Leslie Spring-Pennsylvanian Gas Pool and Leslie Spring-Wolfcamp Gas Pool; and the NW $\frac{1}{4}$ to form a standard 160-acre gas spacing and proration unit for any and all formations and/or pools developed on 160-acre spacing within that vertical extent, including but not limited to the Pecos Slope-Abo Gas Pool. The units are to be dedicated to applicant's Quick Draw Fed. Well No. 1, to be drilled at an orthodox location in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ (Unit D) of Section 23. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well,

and a 200% charge for the risk involved in drilling and completing the well.
