

CASE 13355: *In the matter of the hearing called by the Oil Conservation Division for an order creating and extending certain pools in Chaves and Eddy Counties, New Mexico.*

(a) CREATE a new pool in Eddy County, New Mexico classified as a gas pool for Morrow production and designated as the Cottonwood Draw-Morrow Gas Pool (Pool Code 97377).
