APPLICATION

Edge Petroleum Exploration Company applies for an order limiting the effect of the special rules and regulations for the Dos Hermanos-Morrow Gas Pool (the "Pool") to its current boundaries, and in support thereof, states:

 Applicant is a working interest owner or operator in the N½ of Section 29, Township 20 South, Range 30 East, N.M.P.M.

2. The Pool was created by Commission Order No. R-2938, and currently covers the following lands in Lea County, New Mexico:

3. Commission Order No. R-3351 instituted special rules and regulations for the Pool, providing for 640 acre spacing, with wells to be located no closer than 1650 feet to the outer boundary of the section, nor closer than 330 feet to a quarter-quarter section line.

4. Applicant proposes to drill a well in the N½ of Section 29, to test the Morrow formation. The proposed well is located between the Pool and the Golden Lane-Morrow Gas Pool, which covers, among other lands, the E½ of Section 31, Township 20 South, Range 30 East, N.M.P.M. The Golden Lane-Morrow Gas Pool is spaced and developed on the Division's statewide rules.

5. Applicant desires that its proposed well be spaced and developed on the Division's statewide rules, which provide for 320 acre well units, with wells to be located no closer than 660 feet to a quarter section line.

6. Applicant requests that the special rules and regulations for the Pool be limited to their current horizontal extent, so that wells drilled to test the Morrow formation outside of said Sections 21, 22, 27, and 28 may be developed on statewide rules.

7. The granting of this application is in the interests of conservation, the prevention of waste, and the protection of correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the relief requested above be granted.
