APPLICATION

MARBOB ENERGY CORPORATION ("Marbob"), through its undersigned attorneys, makes application to the New Mexico Oil Conservation Division for an order authorizing Marbob Energy Corporation to conduct waterflood operations in the Dodd Federal Unit Area, comprised of 2400 acres, more or less, of Federal lands located in Eddy County, New Mexico, and in support of its application states:

1. In Oil Conservation Division Case No. 13350, heard by a Division Examiner on October 7, 2004, Marbob Energy Corporation seeks an order pursuant to the Statutory Unitization Act providing for unitized management, operation and further development of a portion of the Seven Rivers, Queen, Grayburg and San Andres, formations, Grayburg-Jackson (Seven Rivers-Queen-Grayburg-San Andres) Pool and the Glorieta Yeso (Paddock) formation, East Empire-Yeso Pool from the surface to a depth not to exceed 5000 feet. The proposed unit area is comprised of 2400.00 acres, more or less, of Federal lands located in Eddy County, New Mexico, and is more particularly described as follows:

TOWNSHIP 17 SOUTH, RANGE 29 EAST, NMPM

Section 10: E/2, E/2 W/2

2. The vertical limits of the unitized formation to be included within the proposed Unit Area extends from the top of the Seven Rivers Formation to the base of the

Glorieta Yeso (Paddock) formation as reflected on the Spectral Density Dual Spaced

Neutron Log for the Marbob Energy Corporation's Mary Dodd "B" Deep No. 2 Well

located 1980 feet from the South line and 1295 feet from the East line of Section 14.

Township 17 South, Range 29 East, NMPM, Eddy County, New Mexico.

Marbob proposes to conduct waterflood operations in the unit area using

injections wells that have previously approved by the Division and additional wells to be

drilled or converted to injection at a later date. the current injection wells are identified

on Exhibit A to this application.

Approval of this application and the implementation of waterflood 4.

operations within the unit area of the proposed Dodd Federal Unit will result in the

recovery of hydrocarbons that otherwise would be wasted and will be in the best interest

of conservation and the protection of correlative rights.

WHEREFORE, Marbob Energy Corporation requests that this application be set

for hearing before an Examiner of the Oil Conservation Division on November 18, 2004

and that, after notice and hearing as required by law, the Division enter its order

authorizing Marbob to conduct waterflood operations in the Dodd Federal Unit Area.
