STATEMENT OF THE CASE

<u>APPLICANT</u>

Applicant seeks an order pooling all mineral interests from the surface to the base of the Morrow formation underlying the following described acreage in Section 29, Township 22 South, Range 27 East, NMPM, and in the following manner: The S% to form a standard 320-acre gas spacing and proration unit for any and all formations and/or pools developed on 320-acre spacing; the SE% to form a standard 160-acre gas spacing and proration unit for any and all formations and/or pools developed on 160-acre spacing; and the NE%SE% to form a standard 40-acre gas spacing and proration unit for any and all formations and/or pools developed on 40-acre spacing. The units are to be dedicated to applicant's Rogers Well No. 1, to be located at an orthodox location in the NE%SE% of Section 26. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of Chi Operating, Inc. as operator of the well, and a cost plus 200% charge for the risk involved in drilling and completing the well.
