APPLICATION

Chi Energy, Inc. applies for an order pooling all mineral interests from the surface to the base of the Morrow formation underlying the S% of Section 28, Township 22 South, Range 27 East, N.M.P.M., Eddy County, New Mexico, and in support thereof, states:

- 1. Applicant is a working interest owner in the S½ of Section 28, and has the right to drill a well thereon.
- 2. Applicant proposes to drill its Skeen Well No. 2, at an orthodox location in the SE%SE% (Unit P) of Section 28, to test the Morrow formation, and seeks to dedicate the following acreage to the well:
 - (a) The SE%SE% of Section 28 to form a standard 40 acre oil spacing and proration unit for any and all formations and/or pools developed on 40 acre spacing within that vertical extent, including the undesignated Wye-Delaware Pool;
 - (b) The SE% of Section 28 to form a standard 160 acre oil or gas spacing and proration unit for any and all formations and/or pools developed on 160 acre spacing within that vertical extent, including the Undesignated North Cass Draw-Wolfcamp Pool; and
 - (c) The S½ of Section 28 to form a standard 320 acre gas spacing and proration unit for any and all formations and/or pools developed on 320 acre spacing within that vertical

extent, including the East Carlsbad-Wolfcamp Gas Pool, South Carlsbad-Strawn Gas Pool, Undesignated Otis-Atoka Gas Pool, and South Carlsbad-Morrow Gas Pool.

- 3. Applicant has in good faith sought to obtain the voluntary joinder of all other mineral interest owners in the S% of Section 28 for the purposes set forth herein.
- 4. Although applicant attempted to obtain voluntary agreements from all mineral interest owners to participate in the drilling of the well or to otherwise commit their interests to the well, certain interest owners have failed or refused to join in dedicating their interests. Therefore, applicant seeks an order pooling all mineral interest owners in the S½ of Section 28, pursuant to NMSA 1978 §70-2-17.
- 5. The pooling of all mineral interests underlying the S½ of Section 28, as set forth above, will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order:

- A. Pooling all mineral interests in the S% of Section 28 from the surface to the base of the Morrow formation;
- B. Designating Chi Operating, Inc. as operator of the well;
- C. Considering the cost of drilling and completing the well, and allocating the cost thereof among the well's working interest owners;
- D. Approving actual operating charges and costs charged for supervision, together with a provision adjusting the rates

pursuant to the COPAS accounting procedure; and

E. Setting a charge of cost plus 200% for the risk involved in drilling and completing the well in the event a working interest owner elects not to participate in the well.

Applicant seeks an order pooling all mineral interests from the surface to the base of the Morrow formation underlying the following described acreage in Section 28, Township 22 South, Range 27 East, N.M.P.M., and in the following manner: The S½ to form a standard 320-acre gas spacing and proration unit for any and all formations developed on 320-acre spacing within that vertical extent, including the East Carlsbad-Wolfcamp Gas Pool, South Carlsbad-Strawn Gas Pool, Undesignated Otis-Atoka Gas Pool, and South Carlsbad-Morrow Gas Pool; the SE1/4 to form a standard 160acre oil or gas spacing and proration unit for any and all formations developed on 160acre spacing within that vertical extent, including the Undesignated North Cass Draw-Wolfcamp Pool; and the SE1/4SE1/4 to form a standard 80-acre oil spacing and proration unit for any and all formations developed on 40-acre spacing within that vertical extent, including the Undesignated Wye-Delaware Pool.
