

2	8:23 a.m.:
3	EXAMINER JONES: And on the fourth page let's
4	call Case 13,386, Application of Marbob Energy Corporation
5	for contraction of the East Empire-Yeso Pool and extension
6	of the horizontal boundaries and the vertical limits of a
7	portion of the Grayburg-Jackson Pool, Eddy County, New
8	Mexico.
9	Call for appearances.
10	MR. CARR: May it please the Examiner, my name is
11	William F. Carr with the Santa Fe office of Holland and
12	Hart, L.L.P. We represent Marbob Energy Corporation in
13	this matter.
14	Mr. Examiner, this case was presented to Examiner
15	Catanach on November the 18th and taken under advisement at
16	that time.
17	On the 24th of November I was called and Mr.
18	Catanach advised me that we had an error in the property
19	description, having sought a contraction of the boundaries
20	of the East Empire-Abo Pool to exclude the southeast
21	quarter of Section 2, 17 South, 29 East, and some other
22	acreage, and in fact what we were needing to do was
23	contract the southwest quarter.
24	We have corrected the legal description, filed on
25	that day an amended Application, have re-notified all

affected interest owners and re-published legal notice for 1 the case correctly describing the property contraction. 2 Exhibit 1 is my notice affidavit. Attached to 3 that is again a list of the parties who have been notified, 4 my notice letter, and return receipts showing that the 5 parties were, in fact, notified.
