The Division filed this application pursuant to 19.15.3.101.M NMAC, seeking an order requiring Verde Grande Inc. to bring the well into compliance with rule 201 by plugging the well, placing it on temporary abandonment status, or returning it to a Division-approved beneficial use by a date certain, authorizing the Division to plug the well if Verde Grande fails to comply, and authorizing the Division to forfeit the financial assurance Verde Grande posted for the well.
