Dear Mr. Brooks:

Paul D. Bliss has given us a copy of your letter to him dated November 8, 2002 for response.

Mr. Bliss disputes the allegations contained in the Application for Case No. 12976. Mr. Bliss attempted to purchase one hundred percent (100%) of the working interest in the Rhonda PG State V-39 Well No.1 ("Well"). An assignment was signed by Mayfair Minerals, Inc., but was never recorded. However, upon further examination Paul Bliss determined that Pace Exploration Co. owned a substantial working interest in the Well. Pace Exploration Co. never transferred its interest to Paul Bliss. Paul Bliss therefore, never obtained the entire title that he was entitled to from Mayfair Minerals, Inc. and since Mayfair did not deliver the entire working interest in the Well to Paul Bliss the transaction was never completed,

In addition since Paul Bliss did not own one hundred percent (100%) of the working

interest in the Well he could not have been elected operator of the Well. He, therefore, has no liability to plug this Well. You should look to Mayfair Minerals, Inc., record operator of the Well and owner of a working interest in the Well for payments of any amounts owing for plugging the well.

Please be advised that this firm will not be attending any hearings on this application on December 5, 2002, if any hearings are necessary.
