SEELY OIL COMPANY ("Seely"), through its undersigned attorneys, hereby makes application for an order amending Order No. R-11929 to eliminate the cementing requirements for the McElvain Federal Well No. 3 located in the SW/4 SW/4 of Section 30, Township 18 South, Range 34 East, NMPM, Lea County, New Mexico and in support of its application states:

1. Seely is the operator of the EK Penrose Sand Unit that is located in the following described acreage located in Lea County, New Mexico:

Township 18 South, Range 33 East, NMPM

Section 24: SE/4 Section 25: NE/4

Township 18 South, Range 34 East, NMPM

The proposed Unit Area consists of 1469.75 acres, more or less, of Federal and Fee lands, situated in Lea County, New Mexico.

2. By Order No. R-11929, entered on April 16, 2003, the Division authorized Seely to conduct waterflood operations in the EK Penrose Unit Area but made remedial action on certain wells a condition precedent to the commencement of these operations.

3. Finding 16, and Order Paragraph No. 9 of Order No. R-11929, requires that prior to injection into the Yates Petroleum Corporation Howe "TG" Federal Well No. 1 ("Howe Well"), Seely must perform remedial cementing operations on the C. W. McElvain Federal Well No. 3 (API No. 30-025-28557) ("the McElvain Well No. 3") as well as another well, to isolate the Penrose Sand member of the Queen formation within that wellbore.

4. Information now available on the McElvain Well No. 3 shows that there is no porosity development in this Penrose Sand in the McElvain Well No. 3.and this sand therefore does not exist at this location.

5. Seely Oil Company therefore requests that Order No. R-11929 be amended to authorize the injection into the Howe Well without first performing remedial cementing work on the McElvain Well No. 3.

6. Approval of this application will eliminate remedial actions that are unnecessary and will other wise be in the best interest of conservation, the prevention of waste and the protection of correlative rights.

WHEREFORE, Seely Oil Company requests that this application be set for hearing before an Examiner of the Oil Conservation Division on March 3, 2005, that notice be given as required by law and the rules of the Division, and that Order No. R-11929 be amended to eliminate the remedial cementing requirements for the McElvain Federal Well No. 3.
