Applicant in the above-styled cause seeks an order pooling all mineral interests in all formations from the surface through the Mississippian Chester formation in the following described spacing and proration units located in Section 20, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico: the S/2 to form a standard 320-acre gas spacing and proration unit for all formations and/or pools developed on 320-acre spacing; the SW/4

to form a standard 160-acre spacing unit for all formations and/or pools developed on 160acre spacing; and the NE/4 SW/4 to form a standard 40-acre spacing and proration unit for all formations and/or pools developed on 40 acre spacing which includes but is not necessarily limited to the Undesignated Willow Lake-Bone Spring Pool and the Undesignated West Willow-Lake Delaware Pool. Applicant proposes to dedicate the pooled units to its Hombre Nuevo "20" Fee Com Well No. 1 to be drilled at a standard gas well location 1980 feet from the South and West lines of said Section 20. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of applicant as operator of the well and a charge for risk involved in drilling said well. Said area is located approximately 2 1/2 miles southwest of Malaga, New Mexico.
