Ladies and Gentlemen:

By letter dated January 2, 2004, ConocoPhillips Company (COPC) as Unit Operator filed the 2004 Plan of Development (POD), which was amended by ConocoPhillips' letter of February 27, 2004. The initial POD indicated thirty-four(34) wells were planned to be drilled and two (2) wells to be recompleted in 2004. The first amendment added three (3) additional wells to be drilled.
