

STATEMENT OF CASE

Applicant seeks an order pooling all mineral interests from the surface of the earth to test the Cherry Canyon formation underlying the S/2SW/4 of Section 10, Township 25 South, Range 28 East, N.M.P.M., Eddy County, New Mexico. Applicant proposes to horizontally drill its Shrike 10 State Well No. 2 H to be located at a surface location of 400 FSL and 2590 FWL and bottom hole location of 400 FSL and 330 FWL of said Section 10. Applicant seeks to dedicate the S/2SW/4 of Section 10 to the well to form a non-standard 80 acre spacing and proration unit for any formations and/or pools developed on 80 acres or less within the vertical extent, including the Cherry Canyon formation. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for

supervision, designation of Lime Rock Resources A, L.P., as operator of the well and a charge for risk involved in drilling said well.


