Enclosed is a copy of the amended application of Mewbourne Oil Company (Oil Conservation Division Form C-108) for approval of a salt water disposal well. Mewbourne seeks approval to utilize its Fairchild "13" Well No. 1 (API No. 30-015-29729) located 660 feet from the South and West lines (Unit M) of Section 13, Township 19 South, Range 25 East, NMPM, to inject up to 10,000 barrels of water per day, at a maximum pressure of 1560 psi, into the into the Canyon (Upper Pennsylvanian) formation in the openhole interval from 7800 feet to 8200 feet.

This application has been set for hearing before a Division Examiner at 8:15 AM on March 31, 2011. The hearing will be held in Porter Hall in the Oil Conservation Division's Santa Fe Offices located at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505. This statement must include: the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party will call to testify at the hearing; the approximate time the party will need to present its case; and identification of any procedural matters that are to be resolved prior to the hearing.
