**STATEMENT OF THE CASE**

APPLICANT

Energen Resources Corporation seeks an order pooling all mineral interests in the  
Fruitland Coal formation, (Basin-Fruitland Coal Gas Pool) underlying lots 5, 6, 7, 8 and the S/2  
S/2 of irregular Section 8, Township 32 North, Range 4 West, NMPM, Rio Arriba County, New  
Mexico, forming a 274.08 acre  $\pm$  spacing and proration unit to be dedicated to the Carracas 8 B

Well No. 16-H. Pursuant to the provisions of Order No. R-13119, the well will be directionally drilled from an unorthodox surface location 2095 feet from the South line and 119 feet from the West line in adjoining Section 9, penetrating the Fruitland Coal formation at a point 1,400 feet from the South line and 400 feet from the East line of Section 8, with a standard bottom hole location 1,400 feet from the South line and 760 feet from the West line of Section 8, Township 32 North, Range 4 West, NMPM, Rio Arriba County, New Mexico. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of Energen Resources Corporation as operator of the well and a charge for risk involved in drilling said well.
