In accordance with Section 10 of the Poker Lake Unit Agreement dated March 18, 1952, BOPCO, L.P. Operator of the referenced unit, hereby submits an Amendment to our 2011 Plan of Development for the Poker Lake Unit.

FUTURE DEVELOPMENT

Poker Lake Unit #312H Eddy County, New Mexico - This well will be drilled at a legal location being 1,100' FNL & 1,750' FEL, Section 33, T24S-R31E, Eddy County, New Mexico to a proposed depth of 8,185' to test the Delaware Formation.

Poker Lake Unit #349H Eddy County, New Mexico - This well will be drilled at a legal location being 450' FNL & 1,850' FEL, Section 10, T25S-R30E, Eddy County, New Mexico to a proposed depth of 7,549' to test the Delaware Formation.

Poker Lake Unit #350H Eddy County, New Mexico - This well will be drilled at a legal location being 1,540' FNL & 2,200' FWL, Section 10, T25S-R30E, Eddy County, New Mexico to a proposed depth of 7,531' to test the Delaware Formation.

Poker Lake Unit #353H Eddy County, New Mexico - This well will be drilled at a legal location being 500' FNL & 2,140' FWL, Section 9, T25S-R31E, Eddy County, New Mexico to a proposed depth of 8,159' to test the Delaware Formation.

Poker Lake Unit #355H Eddy County, New Mexico - This well will be drilled at a legal location being 450' FSL & 1,900' FEL, Section 33, T24S-R31E, Eddy County, New Mexico to a proposed depth of 8,169' to test the Delaware Formation.

Poker Lake Unit #356H Eddy County, New Mexico - This well will be drilled at a legal location being 2,210' FSL & 1,850' FEL, Section 33, T24S-R31E, Eddy County, New Mexico to a proposed depth of 8,192' to test the Delaware Formation.


