Docket Nos. 22-13 and 23-13 are tentatively set for June 27, 2013 and July 11, 2013. Applications for hearing must be filed at least 30 days in advance of hearing date. OCD Rule 19.15.4.13.B requires parties who intend to present evidence at an adjudicatory hearing to file a pre-hearing statement no later than the Thursday before the hearing, and serve a copy on opposing counsel of record. If the OCD does not receive a pre-hearing statement from the applicant by the close of business on the Thursday before the hearing, the hearing may be continued. A party who plans on using projection equipment at a hearing must contact Florene Davidson seven (7) business days prior to the hearing requesting the use of the projection equipment. Wireless internet is available; however, the party must provide its own laptop computer. The following cases will be heard by an Examiner.

1. **CASE 14936:** *(Re-opened): (Continued from the March 21, 2013 Examiner Hearing.)*
Application of Devon Energy Production Company, L.P. to Re-open Case No. 14936 to amend the special rules and regulations for the Northwest Fenton-Delaware Pool, Eddy County, New Mexico. Applicant seeks an order amending the temporary special rules and regulations for Northwest Fenton-Delaware Pool to provide for a special depth bracket allowable of 300 barrels of oil per day for a standard 40 acre oil spacing and proration unit, effective as of November 1, 2012. The pool includes all or parts of Sections 1, 2, and 11-14 of Township 21 South, Range 27 East, NMPM, and Sections 7 and 8 of Township 21 South, Range 28 East, NMPM. The Northwest Fenton-Delaware Pool is centered approximately 7-1/2 miles northeast of Carlsbad, New Mexico.
2. **CASE 14992:** *(Continued from the May 30, 2013 Examiner Hearing.)*
Application of Devon Energy Production Company, L.P. for a non-standard oil spacing and proration unit and compulsory pooling, Eddy County, New Mexico. Devon Energy Production Company, L.P. seeks an order approving a 240-acre non-standard oil spacing and proration unit (project area) in the Delaware formation comprised of the W/2 SE/4 of Section 30 and the W/2 E/2 of Section 31, Township 23 South, Range 29 East, NMPM. Applicant further seeks the pooling of all mineral interests in the Delaware formation underlying the non-standard oil spacing and proration unit (project area). The unit is to be dedicated to the Harroun Trust 31 Well No. 4H, a horizontal well to be drilled at a surface location in the SW/4 SE/4 of Section 31, with a terminus in the NW/4 SE/4 of Section 30. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The unit is located approximately 1 mile northwest of Harroun, New Mexico.
