Re: Amoco Federal 1

The BLM will object to the proposed reinstatement of this salt water disposal well for the following reasons:

- 1. There are numerous wells within the half mile radius around the Amoco Federal 1 that show a calculated cement top rather than a cement top determined by a Cement Bond Log. The BLM does not accept calculated as a legitimate determination of the top of cement. Operator shall provide verification of the cement tops.
- 2. Operator needs to do further research on fresh water wells as there are other fresh water wells in the area.

Note:

Operator is inconsistent in the injection formation – in some places it is listed as Delaware, in others as Cherry Canyon.

Other requirements for reinstatement if objections are satisfied:

The well will be required to have an annulus monitoring system that is open to atmosphere since the cement behind the proposed injection casing does not tie-back into the previous casing string.
