Re: Request for extension of well commencement deadline
Order No. R-13628
Nearburg Exploration Company, L.L.C. ("Nearburg")

Dear Ms. Bailey:

On September 19, 2012, the Division entered Order No. 13628, regarding a well to be drilled in the W $\frac{1}{2}$ W $\frac{1}{2}$ §23-20S-34E to test the Bone Spring formation. The order requires the well to be commenced by October 1, 2013. Nearburg respectfully requests that the well commencement deadline be extended five months, to March 1, 2014. The reasons for this request are as follows: Case No. 14826 ✓

(i) Attached is an exhibit from the hearing, listing all working interest owners in the subject well (34 in total). After the hearing Nearburg continued negotiating with the interest owners, and succeeded in getting all but 4 of the pooled interest owners (totaling 1.4% of the working interest) to voluntarily join in the well (a letter identifying the final pooled parties was filed with the Division). The negotiations delayed well commencement longer than anticipated.

(ii) Nearburg is currently drilling a Bone Spring well in the offsetting E $\frac{1}{2}$ W $\frac{1}{2}$ §23. However, after that well is drilled the rig is contractually obligated to commence four other wells, rather than the well which is the subject of the order. Due to current problems scheduling rigs, this means that the well cannot be commenced by October 1.

The subject well will be located on federal surface, which is subject to Prairie Chicken restrictions requiring well commencement before March 1, 2014, which is why that date is requested.

Your consideration of this request is appreciated.
