STATEMENT OF THE CASE

Among other matters, WPX seeks approval of an unorthodox location for its proposed Chaco 2308-09A 146H Well, which will be horizontally drilled from a surface location in the

NE/4 NE/4 (Unit A) to a non-standard bottom hole location in the SW/4 NW/4 (Unit E) of Section 9. As advertised, “[t]he completed interval for this well will commence in the SE/4 NE/4 (Unit H) of Section 9 and will be non-standard in the SW/4 NW/4 (Unit E).” WPX’s Application also indicates the bottom hole location will be 230 feet from the West line of Section 9, placing the well’s terminus 100 feet beyond the setbacks established for the Nageezi Gallup Oil Pool.

Logos Resources LLC owns the lease interests in Section 8 immediately offsetting the proposed unorthodox bottom hole location. Logos Resources is concerned that the encroachment of the WPX well will impair its correlative rights.




