

To Whom It May Concern:

Chevron Midcontinent, L.P. ("Chevron") filed the above-referenced application with the New Mexico Oil Conservation Division seeking an order (1) creating a non-standard 160-acre, more or less, spacing and proration unit comprised of the E/2E/2 of Section 17, Township 24 South, Range 34 East, NMPM, Lea County, New Mexico; and (2) pooling all mineral interests in the Bone Spring formation underlying this acreage. Division Rules require notice to all operators offsetting the proposed non-standard proration unit. You are an offsetting operator and should have received notice. Due to a broker error, however, notice was not provided. This pooling application, which is enclosed herein together with a letter of notice, is set for hearing before a Division Examiner at 8:15 a.m. on October 31, 2013.

Due to the short time frame involved, there is now insufficient time to provide notice as required by the rules. Chevron requests, therefore, that if you have no objection to Chevron's application we request you to waive any and all objections to the creation of this proposed non-standard spacing and proration.
