21 Chevron?

23 MR. BRUCE: Those cases -- yeah. Those
24 cases can be dismissed.

25 MR. FELDEWERT: Yes, sir.

1 EXAMINER GOETZE: Okay. We have to make it
2 part of the public record. I just wanted to make sure.
3 It's your last chance.

4 MR. BRUCE: Yes. The parties came to
5 terms.

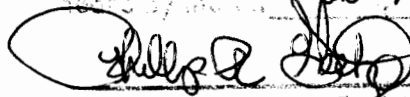
6 EXAMINER GOETZE: Very good. Then those
