25 Are there any other continuance or

1 dismissals?

2 Okay. That is very good. That means our
3 docket today is very light. So this is what I
4 thought, in order so we can, you know, get out of
5 here in one-half hour before the next case.

6 Next, I will look at Case Number 15085 and
7 15086. Could I continue today to collect notice?

8 And then the next one will be Case Number
9 15105.

10 And if it is okay with counsel, I would
11 like to consolidate Case Number 15096 and 15097.
12 That is in the same section.

13 And then Case Number 15102 is to be held
14 by Mr. Dawson. Is that going to to present a
15 problem to anybody?

16 Okay. Very good. We will go with that
17 order and then see what happens.
