If the OCD does not receive a pre-hearing statement from the applicant by the close of business on the Thursday before the hearing, the hearing may be continued. 1. **CASE 15156: Application of OXY USA Inc. for a non-standard spacing and proration unit and compulsory pooling, Eddy County, New Mexico.** Applicant seeks an order (1) creating a non-standard, 160 acre spacing and proration unit comprised of the N/2 N/2 of Section 35, Township 23 South Range 30 East, NMPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Delaware formation underlying this acreage to form a 160-acre project area in this formation. Said non-standard unit is to be dedicated to applicant's proposed **FNR 26 Federal #1H Well** (API Well No. 30-015-42275) to be horizontally drilled from a surface location, 660 feet from the North line and 330 feet from the West line to a bottom hole location 660 feet from the North line and 350 feet from the East line of Section 35. The completed interval for this well will be within the 330-foot standard offset required by the rules. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof in addition to actual operating costs and charges for supervision, designation of OXY USA Inc. as operator of the wells, and 200% charge for risk involved in drilling said well. Said area is located approximately 29 miles southeast of Carlsbad, New Mexico.
