APPLICANT'S STATEMENT OF CASE

Division Order R-13659, entered on November 29, 2012, created a 160-acre non-standard spacing and proration unit in the Glorieta-Yeso formation (Atoka-Glorieta-Yeso Pool (3250)) consisting of the E/2 E/2 of Section 8, Township 19 South, Range 26 East, NMPM, Eddy County, New Mexico and pooled the known uncommitted mineral interest in this spacing and proration unit. This unit is dedicated to COG's proposed Bradley 8 Fee Well No. 4H (API No. 30-015-39813), which has not yet been drilled and is subject to an approved extension of time to commence drilling until December 15, 2014. Since the entry of Order R-14919, COG has

discovered additional mineral interest owners in the Unit that were not notified and pooled under Case No. 14919. COG now seeks to amend Division Order R-13659 to include these additional interests under the terms of that pooling order.


