



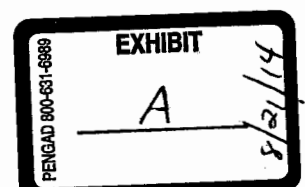

In support of this application, Concho states as follows:

1. Concho is an interest owner in the subject lands and has the right to drill a well thereon.
2. Concho seeks to dedicate the E/2 W/2 of said Section 17 to the proposed well to form a non-standard 160-acre, more or less, oil spacing and proration unit (the "project area").
3. Concho proposes to drill the Goldfinger Fed Com No. 2H well to a depth sufficient to test the Brushy Canyon formation.
