2 order. Today is Thursday, August 21st, 2014. The
3 docket is 26-14. Most of you know who I am. My name is
4 Michael McMillan, and I will be the Hearing Examiner
5 today.

6 The first thing I want to do is go through
7 the continuances and the dismissals, and I'm just going
8 to go through the page and the case number. If you turn
9 to page 1, Case 15188 is continued to September the 4th.

10 On page 2, Case 15161 is continued until
11 September the 4th.

12 Page 3, Case 15162 is continued until
13 September the 4th. Case 15174 is continued until
14 September the 4th. Case 15152 is dismissed. Case 15190
15 and Case 15191 are continued until September the 4th.

16 If we turn to page 5, Case 15185 and Case
17 15175 are continued until September the 4th.

18 Page 6, Case 15176 and Case 15177 are
19 continued until September the 4th.

20 Any other dismissals or continuances?

21 MR. BRUCE: Mr. Examiner, on page 6, the
22 last case, Nadel and Gussman Permian request that that
23 case be continued to September 18th. The parties have
24 reached agreement, and we want to make sure we get the
25 documents papered over. But apparently that case will

1 go away.

2 EXAMINER McMILLAN: Okay. Thank you very
3 much.

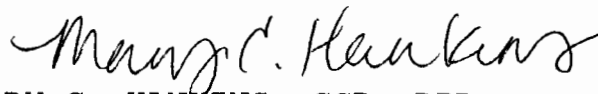
