2 EXAMINER GOETZE: Good morning, ladies and  
3 gentlemen. This is the Oil Conservation -- Oil  
4 Conservation Division Examiner hearings for Thursday,  
5 October 30th, 2014, Docket Number 33-14.

6 First item of business is the changes in  
7 docket cases. First the uncontested cases, on page 3,  
8 Case 15215 has been continued to November 20th. Case  
9 15229 has been continued to November 20th. Case  
10 15230 -- and that's the WPX Energy Production case --  
11 has also been continued to November 20th.

12 Next, the contested cases, 15224. Is  
13 Mr. Hall here? No.

14 Mr. Bruce?

15 MR. BRUCE: Yes, sir.

16 EXAMINER GOETZE: We're going to go with a  
17 continuance, December 4th, as originally proposed.  
18 Hopefully everyone will be able to attend at that time.

19 MR. BRUCE: I won't ask for another one.

20 EXAMINER GOETZE: Very good. I appreciate  
21 that.

22 Well, Mr. Hall, Scott, is not here, so we  
23 will make that an e-mail and addressed to him.

24 Now for the three cases, the gentlemen that  
25 are representing BOPCO, Chevron and -- let's see --

1 OXY -- we've had Case 15192.

2 Mr. Larson, you've asked for -- requested a  
3 December 4th continuance. Any reason why after we've  
4 submitted a grievant [sic] already into record?

5 MR. LARSON: I had submitted a proposed  
6 order, Mr. Examiner, and it hasn't been issued yet, so  
7 the case can't be dismissed until the order --

8 EXAMINER GOETZE: Oh, I understand that,  
9 but you've asked for -- this will be our fourth  
10 continuance. Seeing how we're having a whole day  
11 discussion about SWDs, would it be adverse to have that  
12 also included in the special docket?

13 MR. LARSON: There is nothing to hear.

14 EXAMINER GOETZE: I know there is nothing  
15 to hear, but --

16 MR. LARSON: I'm fine with that.

17 EXAMINER GOETZE: Okay. Let's do that  
18 then.

19 Okay. Gentlemen, what do we got?

20 MR. FELDEWERT: Mr. Examiner, Michael  
21 Feldewert, with Holland & Hart, here on behalf of OXY  
22 USA and Chevron U.S.A.

23 Mr. Larson and I have conferred. We've  
24 also met with our clients. And we would propose, if you  
25 could -- if the Division could do it, having the hearing

1 on December 9th. That's the date that all of our  
2 witnesses -- at least Chevron and OXY, all of our  
3 witnesses can be available on that date.

4 EXAMINER GOETZE: (Indicating.)

5 MR. LARSON: Mr. Examiner, Gary Larson for  
6 BOPCO. My witnesses would also be available on Monday,  
7 December 9th.

8 EXAMINER GOETZE: This is incredibly  
9 simple, gentlemen. As such, let's go ahead. Cases  
10 15192, Case 15231 and Case 15219 will be heard December  
11 9th, Tuesday, out of docket, special.

12 MR. FELDEWERT: Thank you.

13 MR. LARSON: Thank you very much.

14 EXAMINER GOETZE: Very good, gentlemen.

15 And since we are now doing a new process, I  
16 believe we're going to expedite things by going first  
17 with items that have been submitted by affidavit or by  
18 exhibits prior to hearing.
