2 EXAMINER McMILLAN: Good morning. I would
3 like to call the hearing to order. Today's date is
4 Thursday, June 25th, 2015. It is Docket No. 18-15. My
5 name is Michael McMillan, and I will be the hearing
6 examiner today.

7 With that in mind, what I would like to do
8 is to go through the continuances. Case -- if you look
9 at your docket, case No. 1 is continued to until July
10 the 24th --

13 EXAMINER McMILLAN: -- July the 23rd. Case
14 No. 3, July the 23rd.

15 Turning to the second page, case No. 5
16 continued to August the 20th; case 6, August the 20th;

19 continued to July the 20th; case 15303, which is number
20 21, July 9th; and case 15304, continued until July
21 the 9th.

25 EXAMINER McMILLAN: Okay. We are going to

1 do things slightly different than we normally do.
2 Normally, we can follow the docket, but what we're going
3 to do is we are going to hear case No. 15333 first, and
4 that is on page 3.

6 case 15316. The details are on page 5. And then we
7 will hear case 15317.

8 And then, after that, we will be hearing
9 cases 15334, 15335, 15336, case No. 15337, and case No.
10 15338. And then after we hear those cases, we are going
11 to follow the docket.

12 And today, as I said, I will be the lead
13 examiner. Also we will have Will Jones and we will also
14 have Mr. Dawson.
