2 COMMISSIONER CATANACH: We will call the  
3 meeting to order at this time. This is a continuation  
4 of a case heard on September 10th and 11th.

5 Let me call the roll at this time. My name  
6 is David Catanach, and I am chairman of the Oil  
7 Conservation Commission and director of the Oil  
8 Conservation Division.

9 Commissioners, can you please identify  
10 yourselves for the record.

11 COMMISSIONER BALCH: Dr. Robert Balch,  
12 designated Secretary of Energy and Minerals.

13 COMMISSIONER PADILLA: Patrick Padilla,  
14 designated as the New Mexico State Land Commissioner.

15 COMMISSIONER CATANACH: Okay. Today is  
16 October 7, 2015. And this Commission meeting is  
17 in Porter Hall -- I'm sorry. We are in the Wendell  
18 Chino Building in Porter Hall.

19 Commissioners, have you seen the agenda for  
20 today's meeting?

21 COMMISSIONER BALCH: I have.

22 COMMISSIONER PADILLA: I have.

23 COMMISSIONER CATANACH: And do I have a  
24 motion to adopt the agenda for today's meeting?

25 COMMISSIONER PADILLA: So moved.

1 COMMISSIONER BALCH: Seconded.

2 COMMISSIONER CATANACH: All in favor.

3 COMMISSIONER PADILLA: Aye.

4 COMMISSIONER BALCH: Aye.

5 COMMISSIONER CATANACH: The agenda will be  
6 approved.

7 Commissioners, have you had a chance to look  
8 at the minutes of the September 10th and 11th Commission  
9 meeting? And if you have, do you have any changes or  
10 suggested changes to that?

11 COMMISSIONER BALCH: I have no changes.

12 COMMISSIONER PADILLA: Nor I.

13 COMMISSIONER CATANACH: Motion to approve

21 And we have reached a decision and we have a draft order  
22 that we need to take care of today.

23 Commissioners, have you reviewed the draft  
24 order?

25 COMMISSIONER PADILLA: I have not.

1 COMMISSIONER CATANACH: Do you wish to have  
2 some time to look it over?

3 COMMISSIONER PADILLA: No, I saw the  
4 proposed draft order and that's fine.

5 COMMISSIONER BALCH: I read the draft order  
6 and I would move to adopt it.

7 COMMISSIONER PADILLA: I would second that.

8 COMMISSIONER CATANACH: Okay. All in favor  
9 of adopting the draft order say "aye."

10 (In Unison "Aye.")

11 COMMISSIONER CATANACH: Also, on today's  
12 docket was a case, De Novo case 15327, which was the  
13 Application of COG Operating, LLC, for a non-standard  
14 spacing and proration unit and compulsory pooling, Lea  
15 County, New Mexico. This case has been continued to  
16 November 5th, 2015.

17 And do we have any other procedural issues  
18 before we start this case, Mr. Brancard?

19 MR. BRANCARD: No.

20 COMMISSIONER CATANACH: I'm sorry. Mr. Bill  
21 Brancard is also present today. I apologize for just  
22 now identifying you.
