2 EXAMINER GOETZE: Good morning, ladies and
3 gentlemen. Today is Thursday, October 29th, 2015. This
4 is the New Mexico Oil Conservation Division's Examiner
5 Hearing, Docket No. 32-15, in Porter Hall, Santa Fe, New
6 Mexico.

7 I am Phillip Goetze. I am your Examiner for
8 today. And to my left is Gabriel Wade, who is the legal
9 counsel. The first item on the docket will be to look
10 at changes.

11 We are going to start off with Case 15397.
12 That was the Devon -- Mr. Bruce.

13 MR. BRUCE: Yes, sir.

14 EXAMINER GOETZE: Have we gotten any
15 discussion as to a date yet?

16 MR. BRUCE: I think -- I need to talk with
17 Mr. Feldewert again, but --

18 EXAMINER GOETZE: Ms. Kessler, are you
19 also --

20 MS. KESSLER: Mr. Examiner, my understanding
21 is December 3rd; does that sound like what you --

22 MR. BRUCE: That's the regular docket, but I
23 think we talked about a special docket.

24 EXAMINER GOETZE: That's correct.

25 MR. BRUCE: And I need to contact

1 Mr. Feldewert again. We talked about the 7th or 8th of
2 December, but the 7th is a Monday, so maybe the 8th.

3 EXAMINER GOETZE: Let's do this. Let's go
4 ahead and arrange it for December 3rd, and then we will
5 go ahead and advertise after that for a new date. Okay?

6 MR. BRUCE: Sounds good.

7 EXAMINER GOETZE: So Case No. 15397 is
8 continued to December 3rd for an off docket date at a
9 later date.

10 Next on the docket, Case No. 15359 is a
11 correction. It should not be here. It was taken under
12 advisement, so it should be stricken from the docket.

13 Going to page 2, Case 15371, has been
14 continued to November 12th. Case No. 15341 has been
15 incorrectly put into the docket. That is also under
16 advisement. So that shall be stricken from the docket.

17 Case No. 15385 has been continued to
18 November 12th. And Case No. 15386 has been continued to
19 November 12th.

20 And, Ms. Kessler, that is No. 3 for those --

21 MS. KESSLER: I --

22 EXAMINER GOETZE: Keep us advised of what's
23 going to happen.

24 And, then, finally, case No. 15399 has been
25 dismissed.
