**FRONTIER FIELD SERVICES, LLC'S  
PRE-HEARING STATEMENT**

Frontier Field Services, LLC ("Frontier") submits its Pre-Hearing Statement as required by the Oil Conservation Division.

**APPEARANCES**

Frontier is the applicant in this case. Its business address is 4200 E. Skelly Drive, #700, Tulsa, Oklahoma 74135. It is represented by the undersigned counsel. Frontier has not been informed of any opposition to its application.

**STATEMENT OF THE CASE**

Frontier seeks an order authorizing it to inject acid gas and carbon dioxide (CO<sub>2</sub>) from its Maljamar Natural Gas Processing Plant into its proposed Maljamar AGI #1 well. The well will be located in Section 21, Township 17 South, Range 32 East in Lea County, approximately three (3) miles south of the town of Maljamar. Frontier requests approval to drill and complete the Maljamar AGI #1 well for the injection of acid gas and CO<sub>2</sub> in the lower Leonard and Wolfcamp formations in injection intervals between 9,300 feet and 10,000 feet, and approval of a maximum daily injection rate of 2.0 MMCFD and a maximum injection pressure of 2,973 psig.


